NOTICE OF RACE

A cordial invitation is extended to owners of all yachts including one-design keelboats, gaff-rigged and classic yachts to enter this historic event on Australia Day, Tuesday 26 January 2010 on the waters of Sydney Harbour. The Regatta will be conducted by the Royal Sydney Yacht Squadron (RSYS) on behalf of the Australia Day Regatta Management Committee. Ocean-racing yacht owners are also invited to participate in the City of Sydney Sesquicentenary Ocean Race to Botany Bay and return, conducted by the Cruising Yacht Club of Australia (CYCA).

Courses

Courses will be included in the Sailing Instructions issued by the RSYS or CYCA to the entrants prior to the regatta.

Divisions

A minimum of five (5) boats will be necessary to create a separate division.

Prizes

Prizes will be awarded for 1st, 2nd and 3rd handicap places in divisions of five to nine entries. In divisions of one class with ten to fourteen entries, a prize will also be awarded for 1st on scratch. In divisions of one class with fifteen or more entries, 2nd and 3rd scratch placegetters will also receive a prize. Special class and event prizes, together with Perpetual Trophies will be awarded. First placegetters will be invited to the Sydney Town Hall in March 2010 to receive their awards. Prizes for 2nd and 3rd placegetters will be presented immediately after the event or at the annual prize giving of the participating clubs.

Rules

- a) The races will be governed by the current ISAF Racing Rules of Sailing, the AYF Prescriptions and Safety Regulations, the respective class rules, Boating Regulations (Safety Equipment) of NSW, the 174th Australia Day Regatta Special Regulations and the Sailing Instructions as they apply to this event.
- b) Each keel yacht must hold a valid Special Regulations Equipment Audit Form as follows:
 - Category 7 — inshore entries
 - Category 4 — offshore entries
- c) The Regatta is classified as a Category C event in accordance with Racing Rules of Sailing Appendix I, ISAF Advertising Code.
- d) Entrants will be requested to display the event sponsor's name or logo in accordance with Appendix I, ISAF Advertising Code.
